


Report of the Trustees

John Szabo

In-Person Worship:

- Presently authorized for 150 persons
- On-line sign-up for attendees required
- No Temperature check for attendees
- Social Distance seating in Sanctuary
- Masks required to be worn by attendees
- Minimize social contact with other attendees social distancing, masks worn, no physical contact.
- Contact Tracing Maintained
 - Attendee List
 - Photos of Congregation to identify location and adjacency



In-Person Meetings/Use of Facilities:

- Small group usage of church facilities allowed (max. 25 people)
- List of in-person attendees maintained
- Social Distancing and Mask Wearing required
- Approximately 8 small groups meeting
- Coordinate building usage with Michael Deweese

- Maintenance/replacement issues HVAC, exterior painting, etc.
- Updating Asset Replacement Plan for next 15 years for budgeting purposes.
- Continuing to update policies addressing building usage.
- Assessing physical plant assets/technology that need to be acquired to facilitate in-person/virtual/hybrid ministries.



Report of the Finance Committee

Finance

- YTD (January through March) Revenue: **\$307,592** (Budgeted: \$256,500)
- YTD (January through March) Expenses: **\$241,382** (Budgeted: 243, 896)
 - Net income: \$66,210
 *This surplus reflects one time money that was not anticipated in the annual budget.
- Mortgage Balance: \$367,933
- Unrestricted Funds: \$311,440
- Restricted Funds: \$850,377
 - General Endowment: \$151,983
 - Evans Mission Fund: \$220,738
 - *These endowment funds are accounted for as part of the overall restricted funds.
- Comprehensive Financial Plan in May (Debt, Reserves, Capital, Budget Projection)
- Endowment Charter Revisions (Vote needed)
